Donors must be between the ages of 18-26, undergoing a scheduled cesarean section from a full-term pregnancy resulting in a healthy birth. All donors are exclusively from Utah and have undergone extensive bloodwork to ensure the absence of transmittable diseases, as well as to confirm negative results for infections. Our 100% chain of custody guarantees that a Recovery Specialist will collect the postnatal donation and transport it directly to our lab for immediate processing.
